Metaleurodicus minimus (Quaintance): A whitefly

Hemiptera: Aleyrodidae

Pest Rating: A

Comment Period: 09/12/2025-10/27/2025

Initiating Event:

This whitefly is occasionally intercepted on plant material. It has not been assessed with the pest rating system. Therefore, a pest rating proposal is needed.

History & Status:

Background:

Metaleurodicus minimus is polyphagous. Reported hosts include Myrtaceae: Psidium guajava;

Rutaceae: Citrus sinensis; Solanaceae: Cestrum diurnum (Evans, 2007).

<u>Worldwide Distribution:</u> *Metaleurodicus minimus* is reported from: **Caribbean:** Puerto Rico, Virgin Islands; **Central America:** Honduras (Evans, 2007).

<u>Official Control:</u> *Metaleurodicus minimus* is considered reportable by the USDA (U.S. regulated plant pest table).

California Distribution: Metaleurodicus minimus is not known to be established in California.



<u>California Interceptions:</u> *Metaleurodicus minimus* is occasionally intercepted on plant material, for example, guava plants from Puerto Rico (California Department of Food and Agriculture).

The risk *Metaleurodicus minimus* poses to California is evaluated below.

Consequences of Introduction:

- Climate/Host Interaction: Metaleurodicus minimus is only known to occur in warmer climates. It
 is polyphagous, although its known host range is not extensive (see Uncertainty, below).
 Therefore, it receives a Medium (2) in this category.
 - Low (1) Not likely to establish in California; or likely to establish in very limited areas.
 - Medium (2) may be able to establish in a larger but limited part of California.
 - High (3) likely to establish a widespread distribution in California.
- 2) Known Pest Host Range: Metaleurodicus minimus is polyphagous. Therefore, it receives a High(3) in this category.
 - Low (1) has a very limited host range.
 - Medium (2) has a moderate host range.
 - High (3) has a wide host range.
- 3) **Pest Reproductive and Dispersal Potential:** Adult *M. minimus* can fly and this pest can also be spread with infested plant material. Therefore, it receives a **Medium (2)** in this category.
 - Low (1) does not have high reproductive or dispersal potential.
 - Medium (2) has either high reproductive or dispersal potential.
 - High (3) has both high reproduction and dispersal potential.

4) **Economic Impact**. *Metaleurodicus minimus* is plant-feeding and polyphagous. Therefore, it may have the potential to impact a variety of plants. This whitefly is considered reportable by the USDA. Therefore, it receives a **High (3)** in this category.

Economic Impact: A, B, C

A. The pest could lower crop yield.

- B. The pest could lower crop value (includes increasing crop production costs).
- C. The pest could trigger the loss of markets (includes quarantines).
- D. The pest could negatively change normal cultural practices.
- E. The pest can vector, or is vectored, by another pestiferous organism.
- F. The organism is injurious or poisonous to agriculturally important animals.
- G. The organism can interfere with the delivery or supply of water for agricultural uses.

Economic Impact Score: High

- Low (1) causes 0 or 1 of these impacts.
- Medium (2) causes 2 of these impacts.
- High (3) causes 3 or more of these impacts.
- 5) **Environmental Impact**. *Metaleurodicus minimus* could (for the reason explained above, under Economic Impact) impact home/garden or ornamental plantings, and it could trigger treatments. Therefore, this soft scale receives a **High (3)** in this category.

Environmental Impact: D, E

- A. The pest could have a significant environmental impact such as lowering biodiversity, disrupting natural communities, or changing ecosystem processes.
- B. The pest could directly affect threatened or endangered species.
- C. The pest could impact threatened or endangered species by disrupting critical habitats.



- D. The pest could trigger additional official or private treatment programs.
- E. The pest significantly impacts cultural practices, home/urban gardening or ornamental plantings.

Environmental Impact Score: High (3)

- Low (1) causes none of the above to occur.
- Medium (2) causes one of the above to occur.
- High (3) causes two or more of the above to occur.

Consequences of Introduction to California for Metaleurodicus minimus: High (13)

- 6) **Post-Entry Distribution and Survey Information:** *Metaleurodicus minimus* is not known to be established in California. It receives a **Not established (0)** in this category.
 - -Not established (0) Pest never detected in California, or known only from incursions.
 - -Low (-1) Pest has a localized distribution in California, or is established in one suitable climate/host area (region).
 - -Medium (-2) Pest is widespread in California but not fully established in the endangered area, or pest established in two contiguous suitable climate/host areas.
 - -High (-3) Pest has fully established in the endangered area, or pest is reported in more than two contiguous or non-contiguous suitable climate/host areas.

Final Score:

7) The final score is the consequences of introduction score minus the post-entry distribution and survey information score: High (13)



Uncertainty:

There is uncertainty regarding the host range of this whitefly. It has a limited distribution. Therefore, it is possible that the potential host range is much broader than what is reported. No reports were found suggesting that this whitefly is a pest. It is possible that the risks associated with its establishment (if indeed establishment of this species in California is possible) have been overestimated. This approach was taken out of an abundance of caution.

Conclusion and Rating Justification:

Metaleurodicus minimus is a polyphagous whitefly. It could impact plants, including crops, in California, and it is not known to be present in the state. For these reasons, an "A" rating is justified.
